

ORDINANCE NO. 19-07

AN ORDINANCE ADOPTING THE BUDGET FOR FISCAL YEAR 2020
FOR THE CITY OF AVONDALE ESTATES

BE IT ORDAINED by the City of Avondale Estates, as follows:

SECTION 1. Adoption by reference. The document entitled "City of Avondale Estates 2020 Adopted Budget," comprised of the General Fund, the Capital Project Funds, the Enterprise Funds, and the Non-Major Governmental Funds, marked accordingly and attached hereto, is incorporated herein by reference and is hereby adopted as the Budget for the Fiscal Year 2020 for the City of Avondale Estates, Georgia, replacing any and all budgets previously adopted by the City.

SECTION 2. Special Authorization. The City Manager shall be authorized to reallocate departmental appropriations among various line item expenditures of that department as said officer deems prudent.

SECTION 3. Public Record. This document shall be maintained as a public record by the City Clerk and shall be accessible to the public during all normal business hours of the City of Avondale Estates.
