Revenues:

Total General Fund revenues for the month amounted to \$879,265.83. Of that figure; \$550,954.02 was for current year real estate taxes, \$10,509.45 was personal property taxes, \$6,576.51 was for motor vehicle taxes, \$211,727.83 was for the annual insurance premium tax, \$24,759.12 for 278 Design Reimbursement making up the largest portion of collections. Sanitation Fund revenues amounted to \$64,153.00 which included \$167,058.38 transfer BACK to the General Fund. (See Account #'s 1-545-101 – 1-545-430).

Expenses:

Total Actual General Fund expenses for the month amounted to \$280,770.97. Salaries and related fringe benefits (overtime, FICA, group insurance, retirement, deferred compensation match, peace officers' benefit, and workers compensation) amounted to \$184,421.67 or 65.68% of total expenses. Unusual expense for the month was the annual payment for research to ALS/Emory Center for the excess of revenue over expenses for the Labor Day Race proceeds and \$6,800.00 for HVAC replacement at City Hall (see Account 1-580-365 in Capital Outlay. Sanitation expenses for the month amounted to \$64,153.00 and salaries and related fringe benefits amounted to \$42,801.53 of this total or 66.72% of total expenses.

Balance Sheet:

Cash balance in the General Fund operating account, and General Fund Reserve was \$2,297,249.22 as of October 31, 2018. The combined investment balance as of October 31, including interest income amounts to \$507,233.07 for a total cash position of \$2,804,482.29. The Capital Lease – Current (Current Liabilities) decreased \$14,245.48 as a result of the monthly principal payment on the loan associated with the purchase of the land. Each month this account will decrease by the amount of principle paid on the loan (until year end and it will zero out). The interest expense is shown on the operating statement accompanying the Balance Sheet. If you have any questions or concerns, please feel free to contact me.
