Re: June 2019 Financial Position Comments

Revenues and Expenses: Attached is a consolidated statement of activities for the first six months of 2019. Expenses are presented in two ways: departmental totals and city-wide totals by category. Most items shown are within a reasonable variance from the 50% that this point in the year would imply. The exceptions shaded in green and orange were explained in previous reports. June expenditures included a significant software upgrade related to the Police Department's ongoing accreditation efforts (shaded in yellow)

Cash Flows: In April, approximately \$1.18M was deposited in the investment pool Georgia Fund 1 as authorized by the BOMC earlier this year. This account serves as a proxy for the reserves mandated by the City's Fund Balance Policy. The balance in this account represents about 34% of actual 2018 expenditures and slightly over 25% of budgeted expenditures for 2019. The \$1.13M shown in the second Georgia Fund account serves as a proxy for restricted funds held by the City. Other cash balances are also shown below.
